Board Minutes - Highlights

Jan. Meeting

- o Three loads of gravel were received and were allocated as: One load for P-Section, one for the parking lot and one stockpiled for future needs.
- o Teak Street was temporarily barricaded due to it's poor condition.
- o Approved a resolution to petition the County to have Jordan Drive placed under the State Road System (approved by County Commissioners at their Feb meeting).
- o Approved a resolution to open the clubhouse to members one day per week for social/recreational use. Operation to be by Board and Civic League volunteers.
- o Recognized the need to replace a damaged power pole in P-Section behind lots P-4,5 & 6.
- o Approved a resolution to issue membership cards when the current year assessments are paid. Past due assessments to remain on the books and considered an obligation.

Feb. meeting

- o Received a request from the estate of a deceased owner and realtor to settle their back assessments upon transfer of the property to new owners. Referred to our Attorney for legal advise.
- o Announced that there will be a County Roads Hearing to be held at the Courthouse on March 22nd.
- o The clubhouse openings on Tuesdays was announced to be a success with a nice group meeting for games, lunch and socializing.

Mar. meeting

- o The last vacancy on the Board was filled when the Board elected Mrs. Sallie "Sam" Gregory to fill the position left vacant by the resignation of Mrs. Jones.
