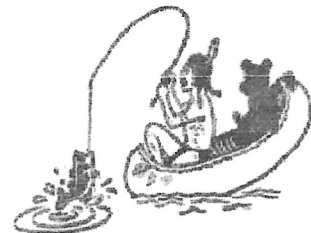

Board Highlights

The annual meeting of the Snug harbor Property Owners Association was held at the clubhouse on November 12, 1994. At this meeting three new officers were elected to vacancies on the Board. They were Leo Higgins, Barbara Russell and Gene Bouch.

There was a lot accomplished over the past year, some of which are set out below:

- The F-Section and C-Section boat ramps were rebuilt and bulkheads repaired.
- Charcoal grills were replaced at the Park.
- Rework was done on the baseball diamond by teens and the Snug Harbor Church.
- The roof on the comfort station in P-Section was replaced and other repairs contemplated.

Since the Annual Meeting there have been two regular monthly meetings and several called special meetings. Although the bulk of the business at these meetings was on the revision of the Restrictive Covenants, items such as the new playground facility (discussion which has been shelved until March) setting a date for an organizational meeting and procurement of new insurance policy for the association was done.

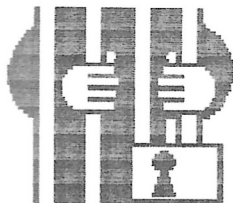


After School Tutorial Program

Teens Line Dancing - Monday evenings from 8 to 9:30 p.m.

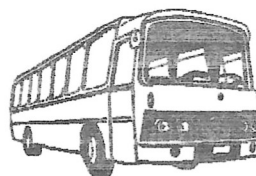
4-H in Action
