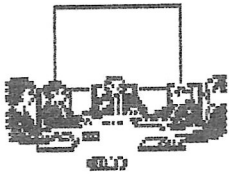
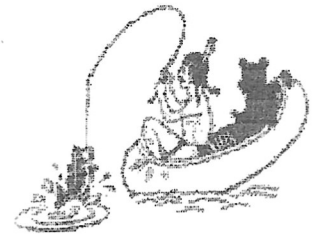
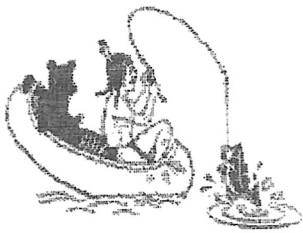

Board Highlights

The Board held it's regular meetings on the second Saturday of the months of April, May and June with a special meeting on April 13. The subjects of these meetings were all-encompassing and at times overlapped the meetings making it difficult to bring forth the highlights covering each of them. Therefore I'll attempt to give a broad perspective of what took place.

First and foremost there was a considerable amount of discussion on the status of the proposed covenants. Although we are at least two-thirds of the way, it appears that the battle will be up hill from here on out. However, don't believe for a minute that the Board has given up on the matter. Every effort is being made to convince property owners of the importance of the proposed covenants.

Elsewhere in this news letter you'll find information on the Boards effort to collect delinquent assessments. Although everything will be done to be completely fair the time has come for all lot owners to pay equal share in financing our community.

Mrs. Russell has agreed to stay on the Board as the representative of "P" Section. This will be helpful for the Board to hear the facts of what is taking place in this area and to do everything possible to bring the area up to standard. Some work are in progress at this time.

The Community Affairs Committee has been very active. They are quite pleased with the reception they are receiving and have noticed that owners are taking an interest in their property.

Thanks should go out to those people who made it possible to open the pool on schedule. Bill Toney not only was in the pool working but was responsible for the equipment used in the pumping out and cleaning before filling with fresh water. Leo Higgins was also on hand and I'm told that Emerson and Jeanne Cullings were also helping. If I missed anyone — Thank you!

ATTENTION DELINQUENT PROPERTY OWNERS

The time has come for the concerns and frustrations of Snug Harbor property owners in good standing to be resolved. It is the obligation of the Board of Governors to enforce the restrictive covenants and make sure all property owners are treated fairly. What is not fair is 68% of the property owners paying for the maintenance and upkeep of our facilities while the other 32% refuse to pay their fair share. As you are aware, all property owners have a legal obligation to pay assessments as outlined in the restrictive covenants. During the next month you will receive a financial statement outlining the amount due and given a one time opportunity to make restitution to the Association. The deadline for making this payment will be 30 days from the receipt of said statement. After the deadline, the board will seek compensation through the courts of Perquimans County or Circuit Court of North Carolina. This decision is based upon the investigation and advise of our attorney. We regret having to take this action. However, we are committed to protecting the rights of those supporting the association through their payments and compliance with the covenants. In order to expedite procedures as soon as possible, the court has been notified as to our commitment and will be making the necessary arrangements for issuing summons' and assigning court dates. We sincerely hope this action will not be necessary. You may avoid this inconvenience and unnecessary legal expense by sending in your payment within the allotted time frame. We understand there may be extenuating circumstances which require special consideration. Should you not be in a position to pay the entire amount, arrangements can be made by contacting me at 426 - 8346. We will be more than happy to work with you in any way we can.

- Dec. 16th Christmas dinner 6:30 p.m. - Santa brings stockings-we the turkey/gravy

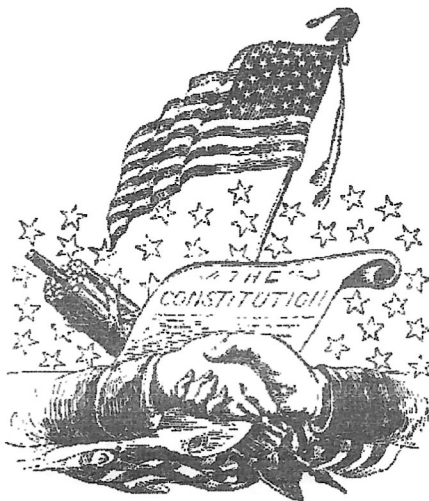
