Board Highlights

January: Injunctions are being sought from District Court to end commercial fishing operations in A-Section. Purchase of a new riding mower approved. Resignation of Mrs. Russell from the Board was approved with regret.

February: Filing of liens against property for which 1996 assessments are unpaid has commenced. It was reported that the County authorities have notified junkyard owners along Snug Harbor Road that property must be cleared up and comply with County Ordinance 22. The cleanup of the Clubhouse by Civic League members was greatly appreciated.

March: Liens for unpaid 1996 assessments have been filed on approximately 100 lots. Hearing on injunction to prevent commercial fishing in Snug Harbor is scheduled for March 21st. (Look for results elsewhere in newsletter). County Commissioners have received progress report regarding junkyards cleanup on Snug Harbor Rd.

March 15th Called Meeting: Members of the Board had met with attorney Nash. Procedures for collecting assessments from lots on which liens have been filed was reviewed.

March 22nd Called meeting: Board approved a Policy for Billing and Collecting of Assessments. See "Assessment & Collection Policy" attachment.

Presidents Corner

As spring rolls around, lawns, gardens, trees and plants certainly are brightening our community. It is also apparent that many good things are happening. Lots are being cleared, foundations and septic systems are being installed, homes are being built and Snug Harbor certainly appears to be revitalized. Easter Sunday's sunrise service was perfect. The park was cleaned of the winter dregs, the weather was warm, the sun rose brightly and there were many residents participating.

Some changes of note that have been accomplished during the winter months; the clubhouse was completely cleaned, the storeroom was organized, the walls, windows, soundproof draperies, kitchen cabinets, floors, refrigerators, ice maker and anything

else in the way was scrubbed down. It really looks nice. New screening was installed on the outside porch and a new cement ramp has been installed at the front door so that we are now handicapped accessible. We have installed a handicapped bathroom stall in the men's room and that stall will be accessible to all. Another major project completed this spring was the removal and replacement of the back side roof and installation of ten roof vents on the clubhouse. The front had been replaced a few years ago after being damaged by a major storm.

The park and the pool will be opening shortly and with the opening, come some responsibilities. These facilities belong to all of us, not a special few. There has been some community input as to the responsibilities of all of us who use these facilities. Those responsibilities are posted as you enter both the park and the pool. Our community expects that all participants at these facilities observe and comply with these few, simple requirements so that everyone can enjoy these benefits. Dog lovers need to take heed. If you want to use the park and you want fido to enjoy it also, put him on a leash and clean up after him. These are family areas also, not just yours.

You will find a separate page in this newsletter entitle "Assessment & Collection policy". Please detach it and put it with your Revised Covenants and Bylaws. Some changes of note: there will be one bill mailed in early January. A past due notice will be mailed after the 1st of April. Delinquent property owners can expect legal action to commence after June 1st. Be guided accordingly.

Thank your residents for keeping the pressure upon the Perquimans County Commissioners and having them enforce the Junk Car Ordinance. Your Association will now begin to work in concert with the Ordinance to rid us of junked and abandoned vehicles. When the community gets involved, good things can be accomplished.

Covenants Court Tested

Your Association went to District Court this year to pursue a property owner who was allowing a commercial venture to be conducted upon his property. On March 21, 1997, Judge Barnes signed a permanent order prohibiting this activity as it is in direct violation of our Revised Restrictive Covenants. Court costs were awarded to the Association and legal action shall commence to collect these costs.

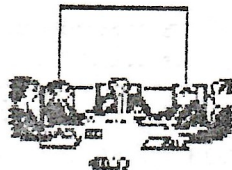

ASSESSMENT & COLLECTION POLICY

Assessments will be billed approximately January 1st of the year that they are due and will be mailed to the last known address of the property owner as determined by Perquimans County Tax Records and Snug harbor Property Owners Association records, and will be considered delivered when posted in the US Mail.

January 1 : Bill for the years assessments will be mailed.

March 31 : Due date for payment of assessments.

April 1 : Notification of Past Due: Approximately April 1 of the year billed, ONE past due notice shall be mailed to the last known address of the property owner stating that the assessment is past due and interest shall commence as per the Revised Covenants and the property owner will be subject to having a lien filed against that property.

April 30 : Past Due Assessments: As per the Revised Covenants, Article IV, Section 7, Assessments shall be considered past due on April 1 of the year billed. If the assessments are not paid by April 30th of the year billed, then interest shall accrue from April 1st at the rate of 6% per annum, and the assessment plus accrued interest shall then be due.

June 1 : Collection Action: 60 days after the due date of the year billed, Snug Harbor Property Owners Association shall initiate the filing of a lien on the property. It shall be at the sole discretion of the Association if further judicial action is deemed necessary to collect the assessment, accrued interest, and collection costs. When the debt is satisfied, the lien shall then be promptly released, thereby unburdening the property.
