President's Corner

It was just about a year ago that I commented about individual responsibilities, community pride, and individual rights. Our community has responsibilities to the folks who live in Snug Harbor and also our community has the right not to be abused. Abuse of our grounds, buildings, park, boat ramps, parking lot, basketball court, tennis court and swimming pool simply will not be tolerated! Show me a community where people have the facilities that we have. Folks, we have it all, right here in Snug Harbor. All of the community areas are for our use. Why would anyone want to destroy them? What is the mentality that causes someone to vandalize any of our facilities or the property of others? When a common area is vandalized, it costs us, you and me, money. Money that could be used for improvements instead of money spent to repair the damage.

The Aesthetics Committee has surveyed Snug Harbor and given the Board a list of properties that need attention. The Board is in the process of sending letters to some property owners indicating that improvements could be made to their properties. The Board has also put some owners on notice that removals are required, and failing to do so, will result in the Association taking the appropriate clean up action, and then billing the property owner for the costs of correcting the deficiencies. Failure to pay these costs will result in a lien being filed, and then, if necessary, commence court action to enforce the lien. If anyone has a question in this regard, please refer to the Amended Declaration of Covenants, Conditions and Restrictions, Article VI, Section 3, in its entirety.

March brought about the second annual "Clean up Snug Harbor Day". Many folks participated in this endeavor. The "trash" was not as bad this year. Thanks to all of the community members who participated. April brought about a "clean up the park" day. What an event! Approximately 50 people participated. Led by Connie Townsend and her gang of young people and their parents and some volunteers, they trimmed trees, painted equipment, raked the grounds, cleaned up the shore line, and gave a general good old fashioned rejuvenation to our valuable asset, the park. What a job you all did. Now that is community spirit. Thanks!

The swimming pool has been revitalized! I am sure participants will be very pleased with its condition. It's almost like a new pool. SHPOA tried a new procedure with the pool during the shut down period. The pump was run at various times of the week with chemicals being added as necessary. All in all, it appears to be a success. We will not have to pump the pool out, clean and refill it, as we have in the past. By incorporating this procedure, we saved about 100,000 gallons of water plus the cost of refilling. The amount of chemicals and electricity used this winter were minimal so we were able to save money.

Have you noticed some volunteers helping the community? We have a group of lumberjacks clearing fallen trees that are blocking some of the canals. We had a volunteer cleaning street signs, a volunteer mowing numerous road sides (especially some of Snug Harbor Road) and the H Section boat ramp, another volunteer cleaning out drainage ditches on Willow Street. We have a volunteer mowing the road sides on the upper end of Dogwood, another volunteer mowing the lower end of Evergreen Drive, and I'm sure, volunteers that I may not have seen or hear about. I think we all could take a lesson from these neighbors. How about stopping to pick up trash along the street or road. How about doing some extra mowing of the road sides in front of lots that are vacant or in front of neighbors who don't regularly get down here. You know, it really doesn't take much to do just a little bit more and if we all could do that, think what the results would be. Incidentally, if you see someone doing that little bit extra, give a toot and a wave. Wont cost you anything. Might show them that you appreciate what they are doing.

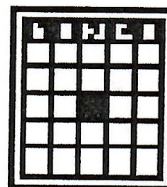
The next Pancake breakfast is scheduled for October 30th.

SWIMMING POOL OPENS MAY 29 – RULES AND REGULATIONS

The swimming pool will be operating from Memorial Day weekend through the Labor Day weekend. Open hours will be:

Saturday, May 29th – 1:00 to 4:00 PM and 6:00 to 8:00 PM,

Sunday, May 30th – 1:00 to 4:00 PM and 6:00 to 8:00 PM

Monday, May 31st – 1:00 to 4:00 PM. Closed Monday evening.

Tuesday, Wednesday and Thursday, June 1st, 2nd and 3rd – closed.

From Friday, June 4th until Labor Day weekend the pool operating hours will be 1:00 to 4:00 PM and 6:00 to 8:00 PM, Monday through Sunday. On Mondays the pool will be closed for maintenance.

The pool will be open on Labor Day, September 6th 1:00 to 4:00 PM and 6:00 to 8:00 PM and will then be closed for the season.

Each person using the pool is required to have a numbered pool tag. Tags may be purchased at the clubhouse office. Office hours are 10:00 AM to 2:00 PM on Saturdays. For the safety and comfort of all pool users, the following regulations will be enforced to insure safe enjoyment by all pool users.

RULES AND REGULATION FOR USE OF THE SWIMMING POOL

PURPOSE: To provide for the safe use of the social and recreational facilities and properties; To ensure the equal use and enjoyment by the members; To provide for the safety of members, their families and authorized guests; AND To establish minimal standards and guidelines governing users of the pool facilities and clubhouse area.

POLICY:

- Members are responsible for observing all pool rules and regulations and are to insure that their guests observe all rules and regulations.
- Parent (members) are responsible for the conduct and safety of their children. Parents shall insure their children observe all rules and regulations.
- Members sponsoring group activities are responsible for the conduct and compliance with the rules and regulations by all members of the group
- **CHILDREN UNDER AGE 12** must be supervised by a responsible adult member
- **ALL SWIMMING IS AT ONE'S OWN RISK**

PROCEDURES:

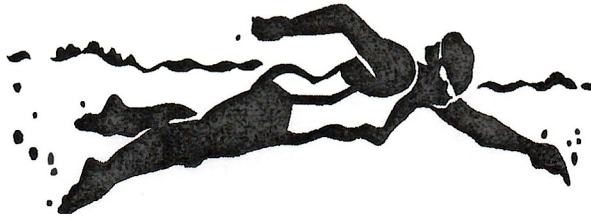
USE OF POOL:

Identification tags are required for entry to the pool area. The tags have elastic bands are to be worn at all times while in the pool area. ID tags can be obtained for one dollar (\$1.00) from the clubhouse during normal office hours. Owners are encouraged to purchase extra tags if they expect frequent guests.

ADMITTANCE TO THE POOL:

All persons using the pool facilities are required to enter their name, ID tag number, and lot number in the log book located in the immediate pool area. The log book is to be signed each day the pool is used.

Tags shall not be loaned to any person, family member, or guest of any owner, whose assessments are in arrears.



GENERAL SAFETY REQUIREMENTS

THE POOL IS FOR THE ENJOYMENT OF EVERY AUTHORIZED USER. Please be courteous to everyone at all time while in the pool area. Improper conduct may be grounds for dismissal from the pool and withdrawal of pool privileges.

FOR EVERYONE'S SAFETY AND HEALTH PLEASE OBEY THE FOLLOWING RULES

- BATHING SUITS ARE REQUIRED
- DO NOT SWIM ALONE-USE THE BUDDY SYSTEM
- RUNNING IS NOT PERMITTED
- GLASS CONTAINERS ARE NOT ALLOWED IN THE POOL AREA
- NO BABIES IN DIAPERS ARE ALLOWED IN THE ADULT OR KIDDIE POOL
- FOOD IS NOT ALLOWED IN THE POOL AREA(except by special approval of the Board)
- ONLY SMALL WATER TOYS OR INFLATABLE TOYS ARE PERMITTED
- ALCOHOLIC BEVERAGES ARE NOT ALLOWED
- NO PETS OR BICYCLES ARE ALLOWED IN THE POOL AREA
- ABSOLUTELY NO PROFANITY OR DISRESPECTFUL BEHAVIOR WILL BE ALLOWED
- PROPERTY DAMAGE IS THE RESPONSIBILITY OF THE RESPONSIBLE MEMBER
- ALWAYS FOLLOW THE POOL ATTENDANTS INSTRUCTIONS

We have been camping in Snug Harbor for over 25 years, our kids have grown up and they come camping with their children.

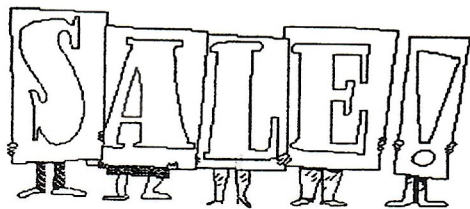
Anybody and everybody is always welcome at our camp site, especially the Saturday night bonfires.
