CHANGES TO ANNUAL ASSESSMENTS

NOTICE -- Your Board of Governors has made two significant changes regarding payment of annual assessments.

- | The first change is that for 2007 the payment due date will be February 28, 2007. That is, payments will be due by the last day of February instead of the last day of March as in years past. You will still have 90 days to pay your assessments, since you will be receiving your 2007 invoice on December 1, 2006, instead of the first of January as in years past. Your Board made this change to move up the process by 30 days in order to have sufficient funds to pay bills at the first part of the year.
- | The second change is that the Board will assess a \$25 per lot late fee on all delinquent 2007 assessments as of March 1, 2007. Unfortunately, it is necessary to take this action because a significant number of lot owners are habitually not paying their assessments until after receiving a second notice.

Also note that the \$25 per lot late fee is being applied against all delinquent 2006 assessments effective July 1, 2006. Unfortunately, the Board is compelled to file liens against those lot owners who have failed to respond to repeated notices.

Please be reminded that the members of your Board are all volunteers and all of your assessments are used for the maintenance and repair of the SHPOA common areas, facilities, and roads.

Pool Tags

Pool Tags are still on sale!! All property owners in good standing are authorized to purchase annual tags for those members of their family that reside with them and an additional two for guests. Tenants are reminded that they must have the form available in the office filled out and signed by their landlord prior to purchasing tags. Children are not allowed to purchase pool tags. **Annual Tags will only be sold during office hours! If you do not buy an annual tag prior to using the pool, the cost of your daily tag, or weekly tag, will not be deducted from the cost of the annual tag.** The pool attendant can only sell daily/weekly pool tags based upon presentation of your 2006 SHPOA Property Owner Card.

\$5.00 Special Assessment Fee

At the April 24th, 2006 Work Session Meeting of the SHPOA Board, the board voted to assess members a fee of \$5.00 to cover the cost of sending certified mail to them. Certified mail is required when notifying owners of Aesthetics or Architectural Violations / Fines, Lien Notices or Notice of Foreclosure. If you receive a certified letter, or even refuse this letter, the \$5.00 fee will be added to your SHPOA account and you will be notified as required

Ditches and Culverts

Several Snug Harbor residents have asked about cleaning the ditches in front of their property. In addition, ditches that are overgrown prevent the flow of storm water and provide excellent breeding grounds for mosquitoes and other undesirable insects. In cases involving ditches along state owned streets, you can call Mr. Swain at the Perquimans County DOT office to complain. On community owned roads we are making every effort to ensure that they remain cut and clean. We ask that whether it is a state owned road or ours, if the ditch abuts your property, you can help all of Snug Harbor by maintaining those ditches free of debris and keeping them cut to increase water flow.

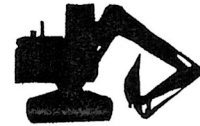

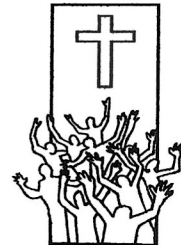

HURRICANE SEASON IS HERE!!

Are you prepared for the upcoming hurricane season? As we move into this season, the board is dedicated to getting as much information out as soon as possible. We will e-mail all information received from the County to all those that we have e-mail addresses for. We ask that you register on the SHPOA website to facilitate this effort. Should you need transportation or special needs, we ask that you look into what assistance is available now! We ask that all of our residents look at their Hurricane Preparedness Plan now and make sure that you have the following:

- **Evacuation Plan:** Make sure you notify relatives outside the area where you are going! Do not wait until the last minute to leave if you are evacuating, or if they issue a mandatory evacuation order.
- **Food and Water:** The National Hurricane Center recommends a minimum of Seven (7) days worth of food and water be on hand for each family member residing with you. Remember to fill things such as your bathtubs and all water containers for flushing water!!
- **Gas and Oil:** If you are staying and you have a generator, stock up on gas and oil!! Remember that even though the local gas stations try and get back online as soon as possible, they too may be without power longer than expected.
- **Medicine:** You should refill all prescriptions early enough to ensure that you are covered. The Family Care Pharmacy in Hertford has provided the following:
 - Try to get your medicine two days before projected landfall.
 - They will be open the day before from 9:00am till 4:00pm.
 - They will reopen as soon as possible afterwards. If they have power they will have regular hours. If they do not have power they will open from 9:00 to 1:00.
 - Bring in your bottles! If there is no power that is the only way they can refill your medicine.
 - If you receive a new prescription, they will give you 2 or 3 days worth until they can get through to your insurance company.
 - Cell Phone Numbers: 339-7020 / 339-5970 / 340-4547
- **Shelters:** We remind everyone that the clubhouse is not an authorized shelter and will not be opened during the storm. The clubhouse will reopen after the storm passes to provide what services we can and act as a central point for getting help to those that need it!!
- **Individuals that have chain saws, heavy equipment and generators:** We ask that you notify us in advance if you are willing to help in the recovery of our community! Please call Steve at 426-5823 to let him know if we can count on you.

PURPOSE:

To provide the Board of Governors with guidelines for collection of assessments that is in accordance to and consistent with the Declaration of Restrictive Covenants and By Laws of the Snug Harbor Property Owners Association and applicable laws.

POLICY:

Assessments will be billed approximately December 1 st for the forthcoming year and will be mailed to the last known address of the property owner as determined by Perquimans Tax Records and Snug Harbor Property Owners Association records and will be considered delivered when posted in the United States Mail.

PROCEDURE:

December 1 st	Bill for the forthcoming year's assessment will be mailed. The invoice will contain a warning that a \$25 fine per lot will be imposed on all assessments not paid by the due date.
February 28 th (29th in a leap year)	Due date for payment of assessments <u>FINE FOR PAST DUE ASSESSMENTS:</u> A fine of \$25 per lot will be imposed on property owners who have not paid their assessments by midnight of the last day of the February due date.
March 1 st	<u>NOTIFICATION OF PAST DUE:</u> Approximately March of the year billed, ONE past due notice shall be mailed to the last known address of the property owner stating that the assessment is past due and interest shall commence as per the Revised Covenants and the property owner will be subject to <u>having a lien filed against that property.</u>
March 31 st	<u>PAST DUE ASSESSMENTS:</u> As per the Revised Covenants, Article IV, Section 7, Assessments shall be considered past due on March 1 st of the year billed. If the assessments are not paid by March 31 st of the year billed, then interest shall accrue from March 1 st at the rate of six percent (6%) per annum, and the assessments plus accrued <u>interest shall then be due.</u>
April 1 st	<u>COLLECTION ACTION:</u> Thirty days (30) after the due date of the year billed, Snug Harbor Property Owners Association shall initiate the filing of a lien on the property. It shall be at the discretion of the Association if further judicial action is deemed necessary to collect the

assessment, fines, accrued interest, and collection cost. When the debt is satisfied, the lien shall then be promptly released, thereby unburdening the property.
