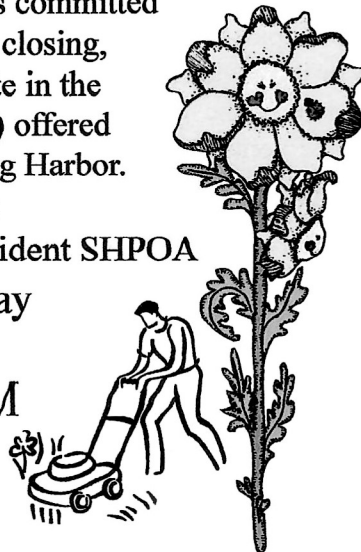

# Civic League Events

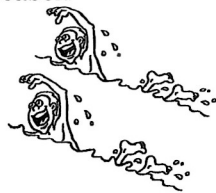

**Community Watch** In the wake of recent break-ins and suspected drug related activity your SHPOA Board is redoubling our Community Watch efforts with stepped up neighborhood patrols and installing camera surveillance equipment and security lighting in key common areas. What can you do? If you witness a crime or have pertinent information of criminal activity call the Perquimans County Sheriff at 252-426-5615-non-emergency, or 911 in an emergency. In addition we are encouraging Snug Harbor residents to install security lights on their property. The Albemarle Electric Co-op will install and maintain a security light for customers for about \$10.00 per month. ## Secretary's Report



Mr. Yerger reported he had made approximately 120 trips to town to pick up mail, and to file and liens at the courthouse. The office hired Ms. Donna Angel as an office worker and the offices are currently being renovated. *Bob Yerger*

## Maintenance & Camping Report



Mr. Nicklin reported SHPOA had purchased a robotic pool cleaner and that it worked wonderfully on keeping the pool clean. Mr. Nicklin reported many of the 9,450 feet of roads belonging to SHPOA received road maintenance this year. Mr. Nicklin stated work had been done on the Septic System in the camping section and many bathrooms had received air hand dryer to help with septic clogging problems. Mr. Nicklin reported work was going well on the office renovation with major electrical, heating, and air conditioning work completed. The replacement of the worn out bulk head in the A-Section Water Park should be completed before the end of the year.

## Architectural Committee

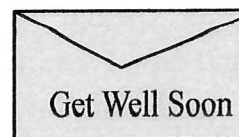

## Community Affairs Report

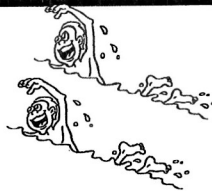

## Park & Pool Update



Mr. Toney reported it had been a great year for the pool and park with 482 passes sold; the weekend passes were successful; there were few incident reports, no injuries, and everyone was cooperative with the pool attendants. Mr. Toney thanked Mr. Miller and Mrs. Swain for their help in managing the pool. *Bill Toney Jr.*

Its hard to believe with all this cold weather its time to be thinking about summer fun. In 2014 SHPOA implemented some new pool passes and will continue to do this in 2016. Daily Pool passes will cost \$2.00, Weekend Pool passes will cost \$3.00 and are good from Friday through Sunday. Weekly Pool passes cost \$5.00 and are good for 1 week. These passes can be purchased by owners and are designed to help owners when they have a large group come to visit and want use the pool. SHPOA would encourage everyone who is thinking about getting their annual passes to do it now before the rush and backup of Memorial Day weekend. As usual, babies in diapers will have to use swimmies diapers to enter any of the pools. Don't miss the Civic League's Summer Pool Kick Off Sat. May 28 at 11PM. Owners and their guests will be invited to use the pool for free on this day.

## Legal Report



Mr. Toney reported there were 2 meetings with the attorney this year, with covenant enforcement, foreclosures and lien filing procedures discussed. Mr. Troy's spreadsheet of owners owing SHPOA money continued to be a very useful informational tool. As of 2015, SHPOA was owed \$78,681, from 92 owners which is about 15% of our membership. 46 liens are currently files with 2015 liens to be filed by the end of November.. Mr. Toney reported the board would continue to work with the County regarding possible foreclosures. *Bill Toney Jr.*

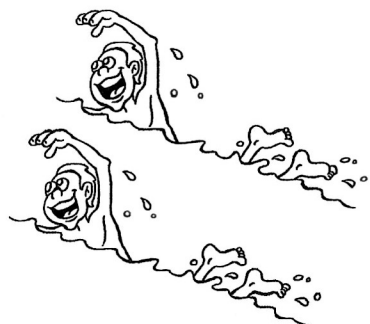
