# Vietnam-era Vets to be Honored

American Legion Post 126 will recognize Vietnam War era veterans on November 11, 2017 as part of the nation's on-going 50<sup>th</sup> anniversary of the Vietnam War.

All living veterans in Perquimans County who served on active duty in the US Armed Services at anytime during the period of November 1, 1955 to May 15, 1975, regardless of location, is eligible to receive a free lapel pin of this Nation's THANKS. You DID NOT have to have physically served in Vietnam.

Perquimans County area veterans who served during this period are asked to contact the Hertford American Legion Post, 426-1679, with their name, telephone, number, and address 24 hours a day. Individuals may also go by the POST located at 111 W. Academy Street, (across from the Perquimans Library) Monday through Friday from 8-9:30 a.m. The DEADLINE is **16 October 2017** which provides the Legion enough time to order the lapel pins.

Veterans are asked to attend the observance on Nov 11 to get recognized and receive their lapel pin. However, veterans who are unable to attend the observance, may pick up their lapel pin at the post when it is open.

## ORDINANCE NO. 95 Perquimans County Noise Ordinance

It shall be unlawful to create or assist in creating unreasonably loud, disturbing and unnecessary noise in the County. Noise of a character, intensity and duration as to be detrimental to the public health, welfare and peace is hereby prohibited.

The following acts, among others, are hereby declared to be unreasonably loud, disturbing and unnecessary noises in violation of this section, but enumeration shall not be deemed to be exclusive:

The sounding of any horn or signal device on any automobile, motorcycle, bus or other vehicle, except as a danger signal, so as to create any unreasonably loud or harsh sound, of the sounding of the device for an unnecessary and unreasonable period of time, or the use of any gong or siren upon any vehicle, other than police, fire or other emergency vehicle:

The use of any electronic devices, stereos, speakers, musical instrument, loudspeaker or other device which project sound that is clearly and audible at a distance of not less than 50 feet.

The use of any bicycle, skateboard or similar vehicle which creates an unreasonably loud, disturbing or unnecessary noises. The use of any motor vehicle, motorcycle or other vehicle (a) equipped with special or custom muffler, exhaust or other noise control equipment/system, or (b) not equipped with normal, factory issue muffler, exhaust or other racing engines, or other operations so as to create unreasonably loud, disturbing and unnecessary noises. The provisions of this subsection shall not apply to any legally operating race track in existence at the time of the enactment of this ordinance.

The erection of any excessive noise on any street adjacent to any school or institution of learning while the same is in session which unreasonably and unnecessarily interferes with the working of the institution provided conspicuous signs are displayed in the streets indicating that the area is in a school area.

The erection of any excessive noise on Sundays on any street adjacent to any church provided conspicuous signs are displayed in the streets adjacent to churches indicating the same is a church street.

Shouting, fighting or creating noise through loud or boisterous speech or singing so as to be audible off the premises upon which the activities and noise occur if so loud as to disturb the peace and tranquility of persons occupying residences, motel, hotels, rest homes, nursing home or hospitals in the vicinity.

( This section shall not apply during any period directly after the announcement of any potential, impending disaster.

( If any person shall violate this ordinance, he or she shall be guilty of a Class 3 misdemeanor and shall be fined in an amount as set by the presiding judge or imprisoned for not more than 30 days.

(In addition, in the county's discretion, a violation of any provision of this ordinance shall subject the offender to a civil penalty of up to \$100. If the offender fails to pay a penalty within ten days after being cited for a violation, the county may seek to recover the penalty by filing a civil action in the nature of a debt. If the violator of this ordinance is a person under the age of 18, the parents or legal guardians of the minor shall be subject to the civil penalties referenced herein as if they are the offender.

(The county may seek to enforce this section through any appropriate equitable action.

( Each day that a violation continues after the offender has been notified of the violation shall constitute a separate violation and each violation shall be subject to an additional civil penalty.

( The county may seek to enforce this section by using any one or combination of the foregoing remedies.

( A juvenile who violates any provision of this ordinance is subject to being adjudicated delinquent. The court may, in its discretion, impose any dispositional alternative(s) that are provided in the State Juvenile Code for any juvenile who is delinquent.

Currently the board President I have served on the board for the past 3 years, working on aesthetics, covenants, pool supervision, and helping get Snug Harbor web page back up and user friendly for all of our Sung Harbor members. I've worked with our county sheriff's department to identify drug and crime issues affecting our neighborhood and attending County Commissioner meetings to Snug Harbor in tune with our County. I would love the opportunity to continue serving on the board, working with fellow board members and community members, listening to your concerns and working to address the issues and/or concerns of our wonderful community and its members.

**Gary Lee Lowry:** I am asking for your I held many leadership and professional positions during my 31 years in the Army before retiring as a Command Sergeant Major. In the last year alone, took the lead on: purchasing an AED for our clubhouse, organizing CPR/AED classes for the community, coordinating the newly elected Sheriff, Shelby White and Deputy Farrer and K9, Roll" to meet our residents, presenting documentation to the County Commissioners to create an Ordinance to authorize golf carts on the roads in the community, persuaded the local American Legion Post to honor all Perquimans County Veterans who served during the Vietnam-era by recognizing them with a Vietnam-era lapel pin. The pin will be presented on November 11 at the annual Veteran's Day ceremony.

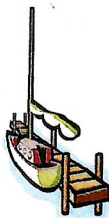
