Snug Harbor 2016 Annual Committee Reports

Presidents Comments 2016 Annual Meeting Mr. Troy thanked the board members for their support, reports, and accomplishments.

Treasurer's Report The 2016 budget of \$127,000. SHOPA was \$128,000 due to improved collections and lower P section utility costs. The lower 2017 budgeted expenditures of \$113,000 are due to completion of the office renovations and the bulkhead replacement in the A-Section Park. With assessment rates being increased by 2%, major capital projects for 2017 include pool upgrades, paving the Handicap area of the parking lot, and finishing the sidewalk and entryway . **Karen Giles**

Secretary/Office reported a multitude of trips to town to pick up mail, and file liens at the courthouse. The new copier is up and running. **Bob Yerger**

Maintenance/Camping Section reported that tons of gravel have been applied to roads throughout the community, mainly in P-Section. Drainage issues were addressed on Spruce St. and some surrounding areas. The bulkhead in the A-Section Park was backfilled and grass planted. Lawn maintenance is ongoing. All of the heavy maintenance activities were much more efficient with the new tractor. **Rodney Franklin**

Legal, By-Laws, & Procedures reported there were 2 meetings with the attorney this year, with covenant enforcement, foreclosures and lien filing procedures discussed. The debt owed to the association owners continues to rise due to 108 delinquent accounts, which is roughly 15% of our membership. 57 liens are currently filed with 2016 liens to be filed by the end of November. The board will continue to work with the County regarding possible foreclosures. **Bill Toney Jr.**

Pool & Park As the newest member to the SHPOA Board with responsibility for the Pool and Park, I want to inform you of the exciting opportunities that will be offered to make your 2017 summer experience more enjoyable. The pool will be open May 27th through September 4th with four special swim times and four community events scheduled, (see activities on pg 4). A SHPOA trained staff member will be present to check-in and ensure the safety of users and monitor activities when the pool is open. The Park is open seven days a week from 6am until dusk. Starting May 27 through September 4, a SHPOA trained staff member may be present to check-in and ensure the safety of users. **Beth Sigler**

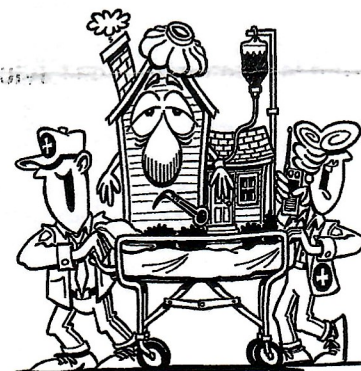

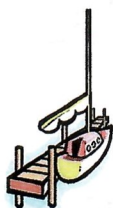
