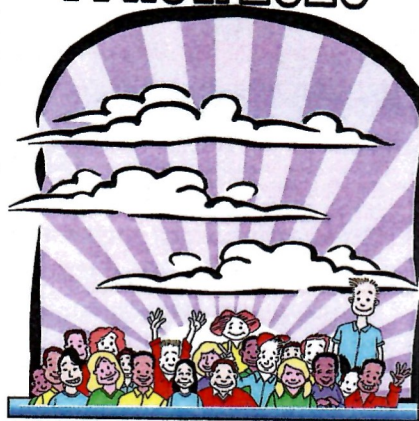

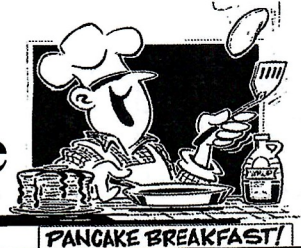


COVID-19 will limit seating to 25 indoors and 50 outdoors. Outdoor seating may be cold and rainy. Masks required.

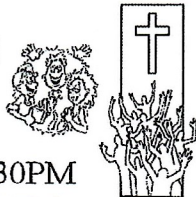

Help keep ditches clean:

When it really rains here in Snug Harbor we can quickly see if street ditches are clogged up. When they clog up they often flood into owner's yards and septic systems. You can help by keeping your street ditches clean and clear. Dragging leaves and grass clippings into the ditch and leaving them, just blocks up the ditch and keeps water from flowing. It also costs the association money when our maintenance has to clean or contract out ditch cleaning. NCDOT can help you if you have a major ditch problem. If you need help you can visit the website, www.ncdot.gov, scroll across the top and click on "contact". On the contact page click on "culvert blockage or drainage Issue" and fill out the form and send it to them. Or call 1-877-DOT-4YOU (1-877-368-4968)

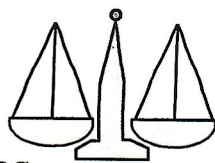

SHPOA Foreclosures

SHPOA is currently owed over \$60,000 in delinquent accounts. Owners have not taken advantage of payment plans and SHPOA has initiated foreclosure proceedings. SHPOA encourages all owners with delinquent accounts to contact the office and initiate a payment plan. Notification of lien filing have been mailed out to owners with delinquent accounts. You may be able to avoid a lien being filed on your property by contacting the SHPOA office at 252-426-5172 and initiating a payment plan.

Owners are reminded that Camping trailers may only be stored on residential lots and may not be used for camping, sleeping or as an additional living or cooking space.

Community Watch

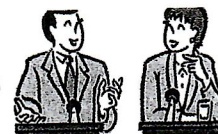
The SHPOA Board has set the 2021 Annual Assessment at \$129 per lot. This is to help pay for the Clubhouse roof and HVAC replacement, basketball court renovation and to maintain our common areas and roads. Camping utility fees will be \$60.

Special Thanks To Mr. Trey Williams Of Paragon Pool Services

The SHPOA Board and all the residents of Snug Harbor want to thank Mr. Trey Williams of Paragon Pool Services for the great work he did in refurbishing our 50 year old swimming and wading pools, making them the best pools in area. When SHPOA could not afford to pay for new coping on the wading pool and planned to try and use old worn out coping from the main pool, Mr. Williams **donated over \$5000 in labor and new coping** to bring the wading pool back to new life. This turned out to be a much bigger job as the entire top of the wading pool had eroded away and a new top of the wading pool had to be cast in concrete to save it. Mr. Williams also donated two new ladders and an additional handrail to Snug Harbor's pool because board members John Williams and Bill Toney Jr. had assisted him in prepping a special roadway into the pool area and removed all the old coping, tile, and debris from the pool. An added thanks goes to Ms. Peggy for refurbishing our sand filters, removing and replacing a ton of sand and gravel, a cup at a time through the small filter openings.
