BOAT PLACARD INFORMATION

After some concerns about the use of boat ramps, the Board of Governors has worked on a system that we hope will help alleviate the issues at all boat ramps. We will be issuing a Boat Placard that property owners in good standing can get for free by registering their boats. When launching a boat at one of the four ramps, the vehicle left in the area will be expected to have one of the placards hanging in their vehicle and a Snug Harbor Sticker on their vehicle, driver's side windshield. A property owner in good standing can also request a temporary placard for their guest that might need to use the Snug Harbor Ramps.

As we complete the details of the Placard use, we are hoping that unauthorized use of the ramps will become an issue of the past.

MEDICAL EQUIPMENT

Snug Harbor POA has gently used medical equipment available for those who are in need. ADOPT-A-HIGHWAY

As we continue to work on keeping Snug Harbor a great place to live, we will continue with our quarterly Adopt a Highway trash clean up. Although we always hope our neighbors are being respectful and not littering, we also realize there are times that trash does end up on our roads. We will post "Do Not Litter" signs and continue to operate the Adopt a Highway program quarterly. Meet us at the clubhouse at 9:00 am on the following days and help us keep the community clean!! For 2024 the dates are Saturdays - Jan 20, April 20, July 20 and Oct 19.

REMINDERS

Night Fishing - After much discussion of the pros and cons of night fishing at A-Park, it was determined that A-Park is currently a dawn to dusk park and is fenced, and gated at night. That leaves the availability of the Ute Street, Pine Street, Willow and Beaver Cove boat ramps open as an opportunity to night fish.

Chickens and roosters have been spotted in Snug Harbor. The Covenants, Conditions and Restrictions, Article VI Architectural and Aesthetic Control; Section 3, Aesthetic Control, All Lots; Item (c)" No animals, livestock or poultry of any kind, other than customary household pets, shall be kept or maintained on any Lot."

POLICY CHANGES

Changes to Policies need to be voted on by the Board of Governors and then distributed to the Property Owners before going into effect. The following are changes to Policies to go into effect.

ARCHITECTURE

We are adding a section 6, a 6B:

If a structure is built without obtaining an architectural application from SHPOA, approved, and building permit obtained from the building inspections office, a fine of \$100 will be an initial assessment and \$25 a week will be assessed until proper application and permits are obtained by the SHPOA office. (Effective October 15, 2023)

CLUBHOUSE RENTAL

f. Property owners in good standing may use the clubhouse for funerals and memorial services at no charge. The scheduling and deposit rules apply.

g. Property owners in good standing may use the building at no cost if the event is open to all Snug Harbor residents and is advertised on the Snug Harbor Facebook page. Deposit and scheduling rules apply. The use of tables and chairs is a rental fee of \$10 per table (including 8 chairs) used. A charge of \$1 per chair would be charged for any additional chairs (not included in table fee).

h. Smoking is not allowed in the clubhouse. Consumption of beer and unfortified wine (15% alcohol content or less - as per Perquimans County) is only allowed in the Clubhouse with prior approval and appropriate insurance coverage.

SECURITY INFORMATION

Due to a certain incidents in Snug Harbor over the summer, the Board has worked on many fronts to upgrade security.

Upgrading security cameras and systems, enhanced lighting and starting a community watch program. We are looking for Captains for each section of Snug Harbor. We have had meetings with interested community members, and have guidelines on responsibilities for the Captains and other members participating. We have been working closely with Sheriff White and will continue to work towards making Snug Harbor the best place to live. "Let's take care of our community.....Together"
