How does the SHPOA board work?

The Board of Governors is comprised of nine volunteer members. Board members are not compensated for their board-related work. The BOG is an all-volunteer working group.

The BOG is governed by the Articles of Incorporation, Bylaws and Covenants and voted onto the board for a term of three years. Each board member can be voted on to serve a second term of three years, then they must rotate off the board. Board members are voted on at the Annual Meeting. All members in good standing get one vote based on the number of lots owned that can be applied to each of the three nominees.

The exception is filling a vacancy:

Vacancies on the Board of Governors shall be filled by a vote of the majority of the remaining governors and a person so elected shall be a Governor until his successor is elected at the termination of the filled term.

The job of a Board is two-fold. One role is policy making and the other is administration. In setting policy, the Board decides what it wants to accomplish while administration is finding ways to carry out the policy. After the election, the current Board of Governors determines the role of each officer for the following year. The Bylaws state that there will be one Annual Meeting a year for members. Currently Snug Harbor Board of Governors host monthly Association meetings open to all members, when a majority of the Board is available. This gives members the opportunity to hear about the work of the Board and to ask questions or voice concerns. The Bylaws also state that the Board of Governors will hold a regular meeting minimally once every two months during the fiscal year. The Snug Harbor Board holds a meeting every month referred to as a Workgroup meeting for the Board to work through the needs and concerns of the Community. This is in addition to the monthly Association meeting.

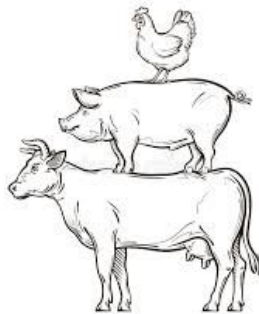
